1) This permit shall remain the property of the Ontario Trails Council. The registered holder shall surrender the permit to the Ontario Trails Council upon written request. The Ontario Trails Council may suspend or revoke an individual trail permit when in their opinion, the individual Trail permit member should not have a trail permit because of failure to comply with the condition of sale of the trail permit, the by-laws of the Ontario Trails Council or the Law of the Province of Ontario. Any suspension of an individual trail permit member may be subject to such Terms as the Ontario Trails Council prescribes.

- c) To be liable for and to hold harmless and idemnify the "Hoat" from all actions, proceedings, claims, damages, costs demands, including court costs and costs on a solicitor and own client basis, and liabilities of whatsoever nature or kind arising out of or in any way connected with my permitted use.
- This permit is valid only when signed by authorized agent.
- 4) Only the vendor organization is authorized to issue a replacement for lost, stolen, or damaged permits. The original trail permit receipt must be presented along with original permit or portion thereof. A processing fee will be charged and other conditions may apply.
- Obey all signs. Abide by the provisions of the Motorized vehicle act, Trespass to Property Act and local Municipal by-laws.
- 6) Stop when requested to do so by a Tmil Warden, Police Officer, or Conservation Authority officer. Report all damaged property io the nearest police officer. Know and adhere to the Ontario Trails Council rules and regulations.
